Trust donors' generosity sees big rise in number of students helped in 2024

The Trust is providing assistance to 21 UKZN students in need this year, up from 15 last year, thanks to a funding boost from the charity's supporters. It is around 20 years since the Trust last was able to help as many students in one year.

The backing will go to seven honours students through Trust bursaries and the Margaret Thomas Scholarship and to 14 undergraduates through book and meal allowances.

The increase has been made possible through significant giving by late alumni Gwyneth Price and Ralph Bennett as well as other donors committed to supporting the Trust's work.

Gwyn's boost for Fine Arts student

The trustees are pleased to have been able to include a young woman studying for a BA in Visual Art among the 21 students awarded help from the Trust this year. It serves as a tribute to artist and sculptor Gwyneth Price (nee Westwood).

The student's selection followed a meeting Gwyn had with Trust Chair Roger Smith in August last year to discuss a donation to the charity. Given Gwyn's own experience as a Fine Arts student on the Pietermaritzburg campus in the 1960s, she agreed it



would be welcome if such a student could be among those to benefit from her contribution today. Gwyn was already seriously ill with cancer at that time and sadly passed away in November.

The trustees believe the funding she gave to help students in need at UKZN will provide a fitting legacy. We feel it is particularly appropriate that a Visual Art BA student is among those selected for 2024, in line with the wish expressed by Gwyn.

Roger attended a memorial gathering for Gwyn in February in Llantwit Major, South Wales, where she had lived with her husband Graham in retirement. There was a good turnout for the event and it was pleasing to see some of Gwyn's artworks on display.



They included a wooden sculpture of a reclining figure, on loan from alumnus Carola Gordon (nee Brotherton). It was a work Gwyn had carved as a student. Carola acquired it in 1966 when she was on the staff of the Fine Arts department

at around the same time that Gwyn was studying there.

Carola is well-known as an artist producing drawings and paintings of Edinburgh aspects, allotments and interior views. She and her husband Martin are longstanding supporters of the Trust.
